consultant, industry thought leader and editor who gives you five guidelines to help you create packaging that delivers to the bottom line.

1. **KNOW** packaging has to fit into your *business strategy*—it's not a matter of "neat new technology." Sometimes a traditional approach is what best meets your business and marketing objectives.
2. **ACCEPT** that retailers rule. Different retailers have different objectives, and packaging may be the key to meeting those needs. Target stores and Costco differ from Wal-Mart and Sam's, and you may have to tailor packaging to a specific channel and retailer.
3. **THINK** shoppers *and* consumers. At the store shelf, the package faces its First Moment of Truth when it needs to grab shopper attention. The point of use is the Second Moment of Truth. Successful packages have to work in both locations.
4. **SEE** global diversity. The BRIC countries—Brazil, Russia, India and China are bellwethers in global markets and packaging is a key in growing economies. The need to have global supply chains to deliver brand consistency is a key.

## SPEAKER'S BIO

**James W. Peters, CPP** is a 25-year veteran of the packaging industry who serves as the Director of Education for the Institute of Packaging Professionals (IoPP). He manages IoPP's growing continuing education program which offers working professionals a series of courses to sharpen their professional skills. He is also Chairperson of The Packaging Summit Conference, an annual high-level event focusing on new developments and strategic packaging directions.

Additionally, Jim has a career as a consultant and a communicator in the packaging field. Credits include:

- Author and editor of multi-client studies, including principal author of *Contract Packaging: Strategic Opportunities* and the study *Club Store Packaging and Beyond*.
- A monthly column, "Peters' Packaging Principles," in *P-O-P Times* magazine and distinguished faculty member of the In-Store Marketing Institute. He has also been a contributing editor for *Packaging World* magazine, where he compiled special reports such as "Driving Brand Sales with Packaging."
- For IoPP, Jim edited the third edition of *Fundamentals of Packaging Technology*, and the second edition of *Transport Packaging*, both valued reference resources in packaging.
- Founding editor of *BrandPackaging* magazine, and Editor-in-Chief of *Packaging* magazine.

**Call To Order-** Chair Dan Best called the meeting to order at 4:05 PM

#### Approval of Minutes-

A motion was made to approve the May minutes. The motion was seconded and approved.

#### Chicago Section IFT Office-

Records are being transitioned to IAMI.

#### Treasurer's Report- Rathna Koka

Fiscal Year (09/01/2006-08/31/2007) Account Summary and Expenditure Reports were distributed.

Audit committee needs to audit books.

Budget is approved as is, recognizing adjustments will be made during the course of the year as needed.

#### Introduction of International Association Management, Inc. (IAM) - Dan Best

Members present were introduced to Lynnda Nelson, Jim Esposito and Nancy Hobart.

#### Survey Monkey Results- Dan Best

More than 20% of our membership replied to the survey. Tuesday meetings are most favored. From this information, meetings will continue to be on Monday for the remainder of this year and then will alternate Monday's and Tuesdays next year. Some interesting comments were made such as: 86 people answered the survey, but don't normally attend the meetings. Attention should be put to finding ways to increase section participation.

#### Suppliers Night- Joe Stout

As of today, all confirmations have already been mailed. This is the first time to have ever achieved this, by this time period. In the past it was usually done by the 1<sup>st</sup> week of October. Everything looks good and optimistic.

#### Current statistics -

- 134 exhibitors have confirmed and paid or are in the process of paying (this is currently at 30% from where we were last year-with 2 more months to go)
- 135 exhibitors have put down deposits- but have not yet confirmed
- 4 cancellations out of the current reserved spaces

-50 exhibitors have put deposits for next year 2008

-last year we had 435 exhibitors and it should be more this year

This should be the final year where you will have to pick up tags which determine the priority ranking in the pre-selection process for 2008. Additional information will be forthcoming to exhibitors. Hours will be from 10:00 PM the night before to 8:00 AM the next morning. Next year we hope to have it online.

Gail Wiseman reported that MFPC has requested a list of Suppliers' Night attendees this year. Lynnda Nelson commented that they should be able to provide it this year. They have an addition of a business card scanner to make work easier, so the list should be available.

#### Special Events/Golf Outing-Mike Hosler

The possibility of holding a golf outing was presented as a means to increase member participation, and offer networking and social benefits. Positive points were raised of the benefits of having a golf outing, giving examples of other section's successful outings such as those held in Great Lakes and Longhorn; with generated funds being used for IFT Foundation scholarships. Questions were raised of poor past performing golf outings where the section lost several thousand dollars. Some concerns were voiced regarding non interested members questioning why we are paying for a golf outing; where 57% of survey monkey responses said they were not interested in a golf outing.

Opinion voiced is that there is no reason for an event like this to only break even or ever lose money.

Current location proposed for this event would be at White Pines Golf Course in Bensenville- (36 holes). The maximum attendees would be 288 with a minimum required of 120.

Proposals discussed would be to tie this outing in with a banquet and to have a booth at Supplier's Night to get publicity and corporate sponsorships.

Current investment required and requested - \$1000 deposit to reserve date of outing.

A motion was made to approve a \$1,000 refundable deposit for securing the date of the outing, recognizing that if outing is not approved at the October meeting, funds will be returned. The motion was seconded and carried with no opposition.

#### **By-Laws-Dan Best/Gail Wiseman**

Changes are needed in the By-Laws first to reflect changes of the elimination of the Councilors. Also, it is suggested that each committee review their sections and make changes accordingly. Changes should be sent to Mona Reinhard who will work with Gail to make adjustments. Gail indicated that the Councilors were eliminated from the IFT so those by-Laws are being re-drafted to reflect that change. New roles for volunteer councilors can be re-defined to still use volunteers in the newly defined role. There is no change in Professional Membership status, but each section can waive this requirement for leadership roles.

## II- Illinois Council on Food and Agricultural Research (C-FAR)

Again this month, the University of Illinois Department of Food Science and Human Nutrition is sharing a brief summary of a research project that is receiving funding from The Illinois Council on Food and Agricultural Research (C-FAR). C-FAR is a statewide partnership organized to support relevant, high-quality research and related outreach programs for Illinois' food, agricultural, and related systems. C-FAR research

funding is provided by the State of Illinois; C-FAR gratefully acknowledges this investment for all Illinois citizens. Since 1995, the Chicago Section of IFT has been a member of C-FAR.

### Intervention Strategies to Improve Microbial Safety of Leafy Greens

The recent outbreak of *Escherichia coli* O157:H7 infections due to consumption of fresh spinach reaffirms the importance and challenge of insuring microbial safety of fresh produce. In 2006, 199 cases of illness related to bagged spinach in 26 states were reported to the Centers for Disease Control and Prevention (CDC, 2006).

Although "Good Agriculture Practices" minimize the chance of pre-harvest contamination, a post-harvest killing step is necessary to ensure microbial safety, especially considering the low infective dose of *E. coli* O157:H7 (ten cells can cause illness). Current industrial scale post-harvest washing of produce, functions only to prevent cross-contamination due to reuse of the washing solution. Apparently this washing step has limited efficacy because, no matter how effective a currently used sanitizer might be

in a laboratory-scale washing test, the microbial counts are only reduced by a factor of 10 or 100 (one or two log-cycles; Sapers, 1998). Therefore, more effective post-harvest disinfection techniques are needed to address the persistent microbial safety problems in fresh leafy produce. However, microbial removal from leafy greens is affected by a number of factors, including the efficacy of the sanitizer and the effectiveness of the washing operation (Zhang and Farber, 1996; Beuchat et al., 1998). Few studies have been conducted to provide a guide to consumers as to the best kitchen washing practice.

The overall goal of the proposed research is to develop practical disinfection strategies for consumers and producers of fresh greens to reduce the risk of bacterial contamination and infection. Head lettuce will be inoculated with *E. coli*, washed for varying times in a variety of sanitizing solutions, and coliform reduction will be determined.

The principal investigators for this study are Drs. Susan Brewer, Scott Martin, and Hao Feng.
