Education: B.S. and M.S. in Animal Science, Ohio State; Ph.D. in Nutritional Biochemistry, Cornell University; Law degrees, Juris Doctor and L.L.M., from Northwestern California University in Sacramento, CA; MBA, Ph.D. in Psychology, and Ph.D. in Economics, Kensington University, Glendale, CA.

Mark Whitacre, Ph.D., has almost two decades of top management experience as CEO, COO & President. Much of Mark's top management experience was obtained at Fortune 500 companies prior to leading entrepreneurial companies, especially in the area of biotechnology and fermentation. He was president of ADM's BioProducts Division from its inception and it became one of the largest fermentation complexes in the world in less than six years. He is now COO of Cypress Systems (www.cypsystems.com) and has worked for companies including Ralston Purina and Degussa.

TOPIC 1

Mark Whitacre is best known for his whistle-blower role in the Archer Daniels Midland largest price-fixing case in history in the mid-1990's. He was the FBI informant of this historic case and wore a wire everyday for almost three years. He was charged and convicted for several white-collar crimes including fraud that occurred during his tenure as president of ADM's BioProducts Division.

Dr. Mark Whitacre was released from prison in December, 2006 after almost nine years of incarceration. During incarceration, Mark set the standard on how one should lead his life. His case of redemption has been nothing less than remarkable, and he has certainly made the most of his second chance.

Mark has often stated that "You do not wait until you are released to get your life in order. From day one, you take responsibility for your actions and begin to chart the course of your second chance." Mark and his wife, Ginger have assisted dozens of couples prepare for prison, and also have assisted dozens of families prepare for the release of their loved one. They continue this service of donating their time to serve others.

In light of staggering divorce rate of 99% for inmates serving over five years in prison, it is indeed a rare occurrence to have a family survive and remain intact during such an ordeal. The Whitacre family not only survived but thrived. His wife (his high-school sweetheart) and children moved to each location that Mark was located and they visited him every weekend.

Their commitment to each other and their solid foundational faith are the bed-rock of this amazing overcoming journey. TOPIC 2
