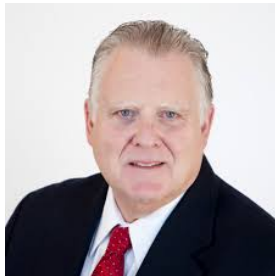
Welcome 2014-2015 Executive Committee Members
